### Chapter Membership Affiliation

1. **New:** December 15 is the Pennsylvania FCCLA affiliation deadline in order for students to participate in STAR Events. (Date approved to begin 2017-18 school year.)

Advisers can affiliate earlier. PA FCCLA recommends affiliating at least 12 members by November 1 in order to have access to all national services including the national affiliation portal that provides the Competitive Events Guide.

2. National dues are \$9 and state dues are \$9. Remit \$18 dues per member and adviser following the instructions on the National FCCLA affiliation website at <http://www.fcclainc.org/>. Click on the "Chapter Login" link at the top of the webpage. If you need help, review the Membership Affiliation documents for instructions through the initial steps of the process, found on the "Join FCCLA" link.

3. Chapters, who have less than 12 members, should call Mrs. Standley for information.

4. Middle level chapters have the option of affiliating all FCS students for a fee of \$750 (\$450 national and \$300 state).

**State Leadership Conference** (SLC): The Annual Pennsylvania State Leadership Conference will be held on Wednesday, March 14, to Friday, March 16, 2018 at Kalahari Resort, 250 Kalahari Boulevard, Pocono Manor, PA 18349.

The deadline to submit conference and STAR Event registration is **January 22, 2018.**

The deadline to reserve hotel accommodations using the PA FCCLA SLC hotel block is February 5, 2018.

**SLC Cost Preview:**

- 1. STAR Event Participant registration fee will be \$10 per STAR Event participant payable to PA FCCLA.
- 2. **New:** Conference registration and your three main meals (excluding breakfasts) will be \$190 payable to PA FCCLA. We did not purchase a buffet breakfast for Thursday or Friday because of the expense (approximately \$50). There are refrigerators and microwaves in all rooms. Everyone should bring foods for breakfast.
- 3. Conference Lodging for two nights is payable to Kalahari. All rooms have two queen beds and a pullout sofa. You may book one to six people in the room. It has one bathroom, refrigerator, microwave, coffee maker, safe, and free Wi-Fi.

There are Two Room Family Suites which have one room with two queen beds and a pullout sofa and a separate room with a king bed. This suite has two bathrooms. These rooms will not be located next to other types of rooms, so your chapter rooms will be separated on different floors. Availability is limited; first come, first serve.

The cost of the Two Room Family Suite for the two nights is \$522.22 which when:  
 divided by 8 is \$65.28 per person, or  
 divided by 7 is \$74.60 per person, or  
 divided by 6 is \$87.04 per person.

**Competitive Events:**

At State Leadership Conference: STAR Events will be held on Wednesday and Thursday. Obtain the Competitive Events Guide through your chapter affiliation portal. There are several STAR Events that are only offered at the Pennsylvania level. Obtain information from the PA FCCLA website <http://www.pafccla.org/general-information/star-events>.
